THE CLINIC BEGAN IN 2001 AND HAS GROWN TO PROVIDE PRIMARY CARE, CHRONIC DISEASE MANAGEMENT, WOMENS HEALTH, HEALTH EDUCATION, PEDIATRIC SERVICES, AND LIMITED MENTAL HEALTH CLINIC. THE CLINIC HAS SERVED OVER 8,471 UNIQUE PATIENTS AND PRESENTLY SERVES AN ACTIVE PATIENT BASE OF APPROXIMATELY 3,000 INDIVIDUALS. CCHC EMPLOYS 35 FULL AND PART TIME PERSONNEL AND 74 VOLUNTEERS TO STAFF THE CLINIC. IN 2015, CCHC ENROLLED 1,124 NEW PATIENTS AND PROVIDED 17,137 PATIENT ENCOUNTERS THAT INCLUDED SERVICES FOR ACUTE CARE, CHRONIC DISEASE CARE, PREVENTIVE HEALTH, AND PRIMARY CARE.
