4a (Code:) (Expenses \$ 1,080,929 including grants of \$) (Revenue \$ 84,596) Charlotte Community Health Clinic, Inc., CCHC, a nonprofit entity providing comprehensive health care services to the low income, uninsured in Mecklenburg County. The clinic began with limited clinical hours in 2001 and has grown to provide primary care, chronic disease management, health of women, health education, pediatric services and limited mental health services. The clinic has served over 5,000 unique patients and presently serves an active patient base of approximately 2,800 individuals. CCHC employs 21 full and part time personnel and 704 volunteers to staff the Services include Acute Care, Chronic Disease Care, Preventive Care, Primary Care and Specialty care services. Specialty care appointments e.g. Diabetes, Cardiovascular, and services for women are available. Ancillary support services include mammograms, health education, access to prescription medications, smoking cessation, Arthritis Exercise and Health Kids Exercise.
