THE CLINIC BEGAN IN 2001 AND HAS GROWN TO PROVIDE PRIMARY CARE, CHRONIC DISEASE MANAGEMENT, WOMENS HEALTH, HEALTH EDUCATION, PEDIATRIC SERVICES, DENTAL SERVICES AND LIMITED MENTAL HEALTH SERVICES. THE CLINIC PRESENTLY SERVES AN ACTIVE PATIENT BASE OF APPROXIMATELY 3,500 INDIVIDUALS. CCHC EMPLOYS 34 FULL AND PART TIME PERSONNEL AND 50 VOLUNTEERS TO STAFF THE CLINIC.
