THE CLINIC BEGAN IN 2001 AND HAS GROWN TO PROVIDE PRIMARY CARE, CHRONIC DISEASE MANAGEMENT, WOMENS HEALTH, HEALTH EDUCATION, PEDIATRIC SERVICES, DENTAL SERVICES AND LIMITED MENTAL HEALTH SERVICES. THE CLINIC PRESENTLY SERVES AN ACTIVE PATIENT BASE OF APPROXIMATELY 4,612 INDIVIDUALS. CCHC EMPLOYS 40 FULL AND PART TIME PERSONNEL AND 39 VOLUNTEERS TO STAFF THE CLINIC.
